1) Introduction

About IIPHG

Indian Institute of Public Health Gandhinagar (IIPHG) is a joint initiative of the Public Health Foundation of India (PHFI) & the Government of Gujarat (GoG) established in 2008. IIPHG is recognized as the first public health university in the country to enact the IIPH Act 2015 by the Government of Gujarat. IIPHG aims to strengthen the country's overall health system through education, training, research, and advocacy/policy initiatives. IIPHG offers full-time post-graduation courses like Master in Public Health (MPH), Master in Hospital Administration (MHA), Post Graduate Diploma in Public Health Management (PGDPHM) And Associate Fellow in Industrial Health (AFIH). Besides academic courses, IIPHG & its faculties are actively engaged in various health systems research and advocacy activities supported by national and international agencies. The institute has worked on maternal health, child health, infectious and non-communicable diseases, environmental and occupational health, climate change, health policy and health systems, and public health nutrition. IIPHG is a hub for excellence in Public Health Teaching, Public Health Innovation, Research and Practice.

About Project

REFLECT is a global multi-center study for evaluating the effects of cool roofs on health, environmental and economic conditions through Cluster Randomized controlled trial (cRCT). This study is sponsored by the University of Auckland and funded by the Welcome Trust, a UK-based charitable organization. Four LMIC sites with poor housing conditions and high solar radiation/external temperature have been selected - Hermosillo, Mexico; Ouagadougou, Burkina Faso; Ahmedabad, India, Niue, Oceania to understand the impact of cool roofs on these diverse communities' health and economic well-being. The long-term research goal is to identify viable passive housing adaptation technologies that are culturally acceptable with proven health and environmental benefits to reduce the burden of heat stress in LMIC communities affected by heat.

Project Objectives:

- Establish community perceptions regarding heat, climate change, and cool roof technology
 and identify cultural acceptability preferences towards LAM-based cool roof approaches,
 processes, and designs for home occupants.
- Quantify the effects of LAM-based cool roof coatings on indoor temperature, energy use, and carbon emissions.
- Quantify the effects of cool roof coatings on human health and well-being.
- Estimate the incremental cost-effectiveness of cool roof coatings compared to standard roofing.

4) Scope of Work

The selected agency is expected to appoint **eight (8) field data collectors** to execute the project activities.

- The data collectors should have a graduate degree and communication skills to work in the field.
- o The data collectors should be well-versed with the local vernacular language.
- The data collectors must have experience in any health-related survey and slum area.
- The field staff is expected to perform baseline surveys and follow-up visits. The detailed plan is as follows:

- The agency is expected to hire **one lab technician** to assess blood glucose using the HemoCue HbA1c501 system.
- This activity will occur twice during the project duration, specifically in the 1st month and the 9th month, with a total of 820 participants each time.
- The field staff will be responsible for the installation of the environment sensors in 410 households. The staff will also ensure that the sensors are working properly. In case of any

technical or mechanical issues, the staff is expected to inform the IIPHG team within 24 Hours.

- The field staff is expected to assist and coordinate with the painter and community when applying the cool roof material to the selected households.
- IIPHG will make all the necessary technical arrangements (access to tools and digital platforms) for the survey.
- The agency is expected to deliver the following reports during the contract.
 - o Submit monthly report
 - o Final report at the end of the contract
 - o Monthly meeting with the IIPHG research team
- 5) Tenure of the Contract: IIPHG will award contract to the selected agency for period of one year. Further extension, if any, will be based on mutual agreement between IIPHG and the selected agency.
- 6) Starting of the project activities: The selected agency will have to start the project activities within 7 days from award of the contract.
- 7) **Site Visit:** It is mandatory for the interested parties to visit the site location at Narol, Ahmedabad.
- 8) Pre-bid Meeting: A pre-bid meeting will be held on 11.07.2024 at 11:00 AM. This pre-bid meeting will be conducted online.
